

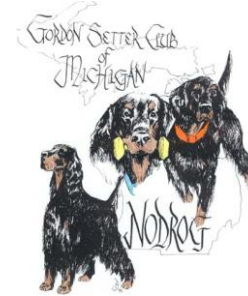

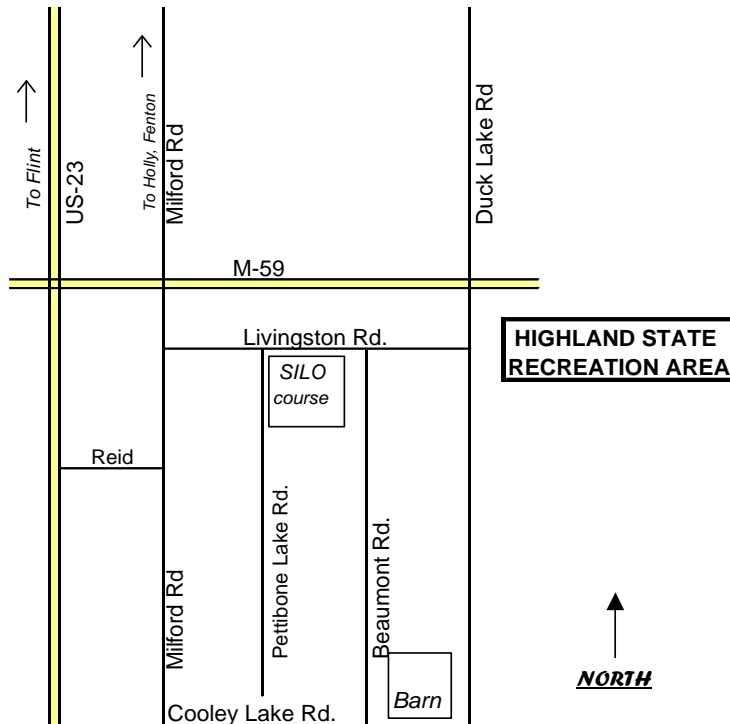

Dogs that first qualify at this trial will not be permitted to enter the Limited Stakes.
